# <u> The Precept 2018/19</u>

The total precept for this coming year will be £31,000; this is made up of the £494 government grant and the remainder of £30506 will be raised through the precept.

This is a decrease of over £500 from central government since last year. We were expecting the Government Grant to disappear totally this year as SKDC are still one of only a few local councils that are still passing this element on.

The total from parishioners living in a Band D household will be increased by approx 2p per week.

This precept will enable us to meet our normal expenditure on services and continue with all the projects already in the pipeline.

Our forward planning for the years 2019/20 and 2020/21 indicate that no major increases should be needed. In fact we will be looking at ways to reduce it if possible.

Looking forward is becoming even more difficult as more services are likely to be passed down to the parish council. Also looking at how the government is expecting the parish to grow in size; we are still not able to fully assess the effects on our budgets. In this Newsletter you will see where some of the money has been spent this year..

With the major building work planned for the Spitalgate area, things will change dramatically with regard to our total electorate.

# Woodland Trust Volunteers

We are now in our ninth year of operation and we are very lucky our membership still continues to grow. This year we have had four new members join, including two female volunteers. The age range of our volunteers goes from early twenties to late seventies. We still maintain the Woodland Trusts Londonthorpe Woods with great feeling of satisfaction. If this was not done the rides would close up, losing many of the excellent walks. Again our fantastic team of volunteers met last season's targets as set at the outset. Our manager at the

trust Ian Froggatt this year arranged and ran a Tree Felling training event. Last year we worked on the Alma Park side of the woods. This season we have worked on two sections where we have opened out one ride that was very wet even during the summer. We

# Harrowby Hill

# STOP PRESS; S17/0566 this application to build 100 homes on this saturated hillside position was refused planning Permission at the SKDC Planning Committee Meeting on the 6<sup>th</sup> February.

SKDC Ward Councillor George Chivers and Pete Armstrong our Clerk spoke against the application. Several residents of the area also spoke against it. This site has many major planning problems to overcome in the view of the SKDC and the PC for it to become viable, in fact we

can't see how it could. It is in the No-Build Red Zone on the Local Plan (SKLP249)! Cllr Chivers and the Clerk included flooding in their reports not only on the site but lower down the Withambrook. Flooding of gardens along Fifth Ave is also a major concern. Grave concerns

were expressed by all on its connection to Harrowby Hill. (Totally unsafe) Other Highway reservations such as the ability of Refuse Freighters to access some areas of the estate especially in wintry conditions could be a further problem

The loss of a vital wildlife corridor was raised by one resident and supported by others, including Lincs Wildlife Trust.

We will keep you the parishioners informed as and when anything further happens.

#### **General Planning Applications**

We have received more than the usual number of applications over the last year. All applications go out to all councillors for their observations, five of whom are selected to report

back to the Clerk. This information is formulated into a reply to SKDC Planning. This year we have formed a planning committee to deal with any applications that are deemed likely to cause a problem. The five members then go through the application in finer detail before submitting the comments to SKDC Planning. Any councillor can ask for an application to be brought before the committee.

# Hare Coursing

Unfortunately Lincolnshire continues to be one of the areas most frequently targeted by coursers – the illegal act of setting dogs to chase and kill hares. You can help Lincolnshire Police fight hare coursing by looking out for activity in our area. there have been sightings within the parish. The most obvious sign is groups of vehicles parked in a rural area, perhaps by a gateway to farmland, on a grass verge, on a farm track or bridle path. They will usually be estate cars, four wheel drives or vans. It will be obvious looking inside whether there is evidence of dogs or not. They often travel in convoy, with vans at the front and rear containing minders. They will often use binoculars to spot hares. Coursers will often walk along the edge of a field to frighten a

They advise that you do not approach the participants, but do make a note of vehicle registration details and take photographs if it is safe to do so. Please report all sightings on 101 or if the hare coursing is in progress, dial 999.

#### PLANNING AROUND THE PARISH SPITALGATE HEATH-SOUTHERN QUADRANT

As stated elsewhere we are still waiting for this application to come back in; it was before the SKDC Development Committee in the autumn of 2017. The Parish Clerk spoke on behalf of the council raising several points that we want clarifying. These are such things as a set timetable of

events e.g. when are certain things going to come on board such as the village centre and schooling. We are informed that no more than fifty homes will be built in the first year of development. We want to have complete clarity of when the Relief Road will be completed as there is a maximum numbers of homes that can be built prior to that. Considerable resources are being committed by the developers to the assessment of the application before putting it before the Planners. The process is still going to be very long and thorough. The applicant is making every effort to supply as much information as is possible so that all concerned are able

to consider every aspect of the proposed development, in order to make a well informed judgement. The amended application is still awaited by SKDC and will only go before the SKDC Planning Committee when it has been fully assessed. We will have a say at this time and will

insist that our agreements made with the developers previously are included. We wonder if the fact that the same developers have now got permission for the Outlet Centre

#### means it has taken precedence Grantham East West Relief Road

Phase one of the Relief Road was completed in August 2016 and saw the creation of a roundabout off the B1174 and a road along Tollemache Road that leads to a second new roundabout.

2018 in Grantham has kicked off with on-site archaeological works near the A1 starting, signifying the continuation of preliminary works as part of the £81m project's second phase. Allen Archaeology, the firm tasked with undertaking the nine-week investigation, started work earlier in January and are expected to complete their works on-site by the end of March.

Initial archaeological investigations have already been completed for phase three and at the beginning of January the county council's executive gave officers the green light to pursue the necessary legal orders and land acquisitions for the project.

When complete, the relief road will link the A52 at Somerby Hill to the A1, attracting a significant volume of traffic, including HGVs, and resulting in a reduction in congestion in Grantham town centre.

Cllr Richard Davies, Executive Member for Highways and Transport, said:

"Building a major new road like the relief road involves a lot of preliminary work before tarmac can be laid. A major aspect of these works is carrying out a thorough archaeological investigation to protect the heritage of the area before we start building.

"Whenever you're building a big piece of infrastructure, like Grantham Southern Relief Road, it's incredibly important that work is carried out to gain a better understanding of the heritage and history that can be found just below your feet. From this, future generations then have the chance to learn and understand what was happening on-site thousands of years ago."

#### Somerby Hill Proposed Planning Application

As many of you will have heard the application for around 250 homes on Somerby Hill was rejected by SKDC and then on Appeal by the Inspector. We would hope that is an end to that but it is expected a further appeal will be lodged in the near future.

The main point for refusal quoted by the inspector was the proximity to the Prince William Gloucester Barracks and Industrial site. One of our main objections was also that this is on the Grantham Local Plan as a no build area.

With prudent budgeting the Parish Council has been able to repay the mortgage early, thus saving a considerable sum of interest. The Voluntary Working Party Group is also doing a tremendous job of improving and maintaining the area to enhance its role as a SSSI nature reserve.

The Parish Council has five play areas, and part of our role is to maintain and improve these areas. This year we used a different Safety Inspector whose report was very comprehensive. Due to this we have been able to do a complete maintenance up to date, knowing now that everything is as safe as it can be. This is allowing full use by a considerable number of parishioners.

I am also pleased to announce that the old wooden trim trail in the Belfry area is to be replaced this coming year with a more modern trim trail. The old equipment is simply worn out but the Chairman of the Parish Council has said he will recycle some of the wooden posts by making them into benches.

I set myself a task this year of walking the Parish boundaries to see if any old markers were still visible. I have almost completed my journey and unfortunately there is very little to report so far, except where the boundary crosses Belton Park.

The boundary follows the river from Belton Lane to well within the Park. Where it emerges is an old Mews House, the only one in the park. As you walk up the boundary there are two walnut trees in a small spinney, originally there had been three. On into the large deer field a number of oak trees mark the old boundary hedge, including the Park's oldest tree, which is now fenced in to prevent the deer from damaging it. The boundary then leads into and through Belmont Tower wood towards Pvewipe Cottages on the High Dyke. It then follows the High Dyke to Old Somerby roundabout and beyond the Rugby Club. The boundary then turns west towards Spittlegate Level and follows the river to just north of Paper Mill Farm before turning back east to cut through the middle of the Bridge End Road Estate taking part of the Eatch's Estate. With the Prince William of Gloucester Barracks and the Hills and Hollows on the south east of the boundary. Two black and white parish boundary markers can be found here, one on Bridge End Road and the other on Cold Harbour Lane. The boundary here does some wandering off a straight line but turns North just below Harrowby Hall and across to the Green Lane that leads from Belton Lane, it then drops back to the river as the final boundary line. You may have seen the Black & White marker post on the left as you leave Grantham.

The Parish Council also maintains the footpaths in the Parish for the benefit of walkers and runners, and it is gratifying to see so many parishioners using these paths. The dogs seem to like them too.

Unfortunately, we do experience a small amount of vandalism and I ask anyone who notices any such damage to report it to the Clerk of the Parish. If you witness damage being done, please do not confront the person or persons, please just ring the Police on the non emergency number of 101.

As Chairman of the Leisure and Outdoor Committee, I wish to thank the Clerk of the Parish for his tireless work; the Parish Cleaner for his contribution and the volunteers who make up the Working Party for their sterling work, not only at the Hills and Hollows but also in conjunction with the Woodland Trust for the work in Londonthorpe Wood. #### OPEN EVENING

September's Open Evening once again proved to be a great success with many residents attending to speak to representatives on several different subjects.

All projects ongoing in the Parish were once again displayed around the hall. The main areas covered this year were the updates on planning applications around the parish. There were four that have proved controversial including one for 100 homes on

Harrowby Hill behind Fifth Ave, one for a planned Travellers Site on Harrowby Lane, Harrowby. The latter was passed by SKDC Planning with restrictions applied; *the first one is still ongoing. We will be speaking against this as a Parish Council when it comes to the Committee stage including what was said by parishioners on the night and since.* The others were the major development at Spitalgate Heath and the Somerby Hill application. Somerby Hill was refused permission by SKDC Planning and went to appeal; this was also turned down. Spitalgate Heath is now to be considered as a "Garden Village" with some additional funding having become available to SKDC because of this. The revised plans are not now expected until the March meeting at the earliest.

We had visiting stands from both the Red Cross, plus the Veterans Association who have unfortunately had to cease functioning due to their funding being withdrawn. This year's "Tom Childs Award", the eleventh, was held at the Officers Mess at Prince William of Gloucester Barracks. Paul Bakker, the Chairman of Londonthorpe & Harrowby "Without" Parish Council welcomed all the guests.

Unusually this award went jointly to a husband and wife team. The winners were Dave and Joan Chambers. How can you separate a couple who have both put in tremendous amounts of their free time to work for others for nothing?

They were proposed by Matthew Davidson the head teacher at Belmont Primary School. They both started volunteering at Belmont when their granddaughter started in

Reception 6 years ago. They have worked tirelessly throughout with Joan working mainly in Reception/Early Years. She undertakes many tasks from listening to children read to helping in small groups as directed by the teaching staff.

Out of the classroom she can be found preparing wall displays plus much more. Dave has worked on many other things within the school environment besides helping doing some of the same sort of tasks as Joan. He is also a bit of a handyman to say the least; during the time that the school was without a caretaker last year he carried out many maintenance jobs. Last summer he was painting the Early Years Area fence along with other repair work and gardening.

# Hills & Hollows Nature Reserve

One of the most ambitious projects undertaken over the last few years was the purchase of the land known locally as The Hills & Hollows. This year we have paid off the mortgage in full. This will save us over £1000 over the time remaining on the loan. This of course has depleted our bank balance at present but this will recover during the next two years. This area is now a protected Nature Reserve

which will hopefully, in years to come ,be listed as a Site of Special Scientific Interest (SSSI).

We are continuing with improvements year on year; if you have visited recently you will have noticed how the Memorial area is much more open. The Working Party in January cleared away approximately three metres of ivy covered vegetation, thus opening up space for at least two more memorial trees.



All the land in the area has now been sold, unfortunately we don't know who to in most instances. Those that we do know about, we are working very closely with to improve all the areas used by people for whatever fitness activity they are involved in. We have seen dog walkers, joggers, hikers and wildlife enthusiasts. On the downside we have also had problems with motorcycles tearing up the area. Under the terms of our purchase it is illegal to ride/drive any motor vehicle on our land unless being used during maintenance etc.

The Working Parties as mentioned above continue with the general maintenance of the area, a lot of the work undertaken is repairing damage done by vandals. At the last event eight new signs and boards had to be erected to replace those lost to the vandals. This of course incurs a cost to the Parish council and consequently you the parishioners.

A smaller working party will be arranged in the spring to burn the brash from the latest event. The Bluebells planted last year gave us some new colour but not as much as expected, we hope this will be better as time goes by and they start to form clusters. Also last spring a trial of planting Native Snowdrops was undertaken. We hope to see benefits of that in the next few weeks. Work continued during the whole of last year and was undertaken by the Parish Council Chairman Paul Bakker and Pete Armstrong the Parish Clerk. They sprayed the hedge bottoms with weed killer which then encourages better growth of the young saplings. Although it is fair to say that the hedge has made tremendous growth, it's at the stage where we have to trim it back. Our Community Cleaner Tony Parker also makes regular visits doing repairs as required. We are very grateful for those users who regularly collect and take other peoples rubbish home with them. The police are aware that we are still getting criminal damage and we would ask that, if you see any vandalism or unsocial behaviour taking place please call the police on 101 and if possible also contact the Clerk.

If you see a problem, blocked path ways or damage, please contact the clerk or your local councillor. We are always looking for more volunteers, the group at present is made up of residents and councillors. At times they have also had volunteers from The Duke of Edinburgh Award Scheme!
