The Parish Council will be continuing to work with the National Trust towards a long -term solution. We have also been assured that the Parish Council will be fully consulted on any future plans at the Lion Gates entrance, and we will maintain a dialogue and hold further meetings with the National Trust going forward.

## **<u>A Town Council for Grantham?</u>**

South Kesteven District Council is undertaking a Community Governance Review to establish if there is support for the creation of a town or parish council for Grantham which could include parts of neighbouring parishes.

Grantham is the only town in South Kesteven which does not have a town council. This came about due to the reorganisation of local government in 1974 where at the time it was decided that Grantham should only have Charter Trustees. There are 15 Councillors who represent the old borough of Grantham whose only remit is to select the mayor and set the budget.

The office of Mayor Precept is funded only from those residents living in the old Borough of Grantham.

Town and parish councils represent their communities for example in the provision of allotments, burial grounds, cemeteries, parks, and recreation grounds. Public conveniences, litter and play areas are functions they can administer which are currently run by the District Council. Another area is in crime prevention and markets. What they cannot do is Highways, Adult Social Care, School transport and Fire Prevention which are carried out by the County Council.

An important question often asked is how much would this cost?

Clearly the cost of running a Town Council would cost more than the current charge. A new Town Council precept would be determined by the town council although if created SKDC would set its first-year costs.

Currently the total electorate is 28,508 for the purposes of the District Council elections. Areas currently outside the old borough boundary which could be considered to join the council are – Grantham St Wulframs, Belton & Manthorpe and Rosedale ward. 234 electors – 111 properties

Grantham St Vincent's, Londonthorpe and Harrowby without Parish, Bridge End ward. 343 electors – 189 properties

Grantham Arnoldfield, Great Gonerby Parish, Gonerby Hill ward. 173 electors – 78 properties

The National Association of Local Councils suggests that the minimum number of Councillors should be 7 and the maximum 25. Please note that no allowances are paid except for expenses.

When the Community review is launched various organisations will be consulted including all Parish Councils neighbouring the unparished area, local government electors in the area under review, Members of Parliament, SKDC, LCC and any other organisation who appear to have an interest.

## Leisure & Outdoor Committee Overview

In last April's newsletter I outlined the improvements we had made to the Londonthorpe amenity area including the laying of the roadside hedge. Since then the number of visitors using the site has increased and we have received many positive comments from members of the public. One even stating they didn't realise the play area existed before. Due to Covid-19 restrictions in early 2021 we were unable to purchase the shrubs and trees required to fill in the gaps in the hedge. However, in the autumn we were successful in an application to Lincolnshire County Council Treescapes Planting Scheme, these have now been delivered to us and planted by our volunteers.

They are of a mixed species to give the hedge a more diverse feel. Along with these hedgerow saplings we received both Oak & Rowan trees which are interspersed with the Wild Cherry already there.

The Hills & Hollows conservation area continues to be very popular with walkers, both those with and without dogs. I'm pleased to say a seat, made from the polished granite slabs donated by Vale play equipment in 2020, was finally installed last summer. This is a great addition to the site and provides a welcome resting point as well as a great view towards Grantham and Belvoir Castle. More trees have been donated and planted and an area of grass was cut in the autumn to encourage fresh



growth and hopefully improve the diversity of plant species growing on the site. The Council has made a further investment in our play areas by replacing the worn out wooden trim trail at the Withambrook with a mainly metal one and some rubber stepping stones. Both have been well used since their installation. It was also decided to lay an all-weather footpath, made from resin bound wood chips, from the Withambrook bridge to the Ruston Road entrance. This section was always very muddy previously and we felt it was an important improvement to make. Unfortunately, the land on the Sunningdale side of the bridge is not under our control, so we are unable to extend the path on that side. Likewise, we are still unable to install a footbridge linking this area to Third Avenue until LCC's flood prevention team have made a decision on whether to install an attenuation pond or not.

I would like to finish by thanking everyone who has volunteered on Council led projects in the past year, including those in conjunction with the Woodland Trust. Some of these people do not live in the parish or even in Grantham; thank you for your continued and much welcome support.

## **Planning Update**

The Parish Council has received details of all planning applications within the parish for our consideration and to submit comments to the SKDC Planning Department. Applications considered have included residential builds and extensions, industrial properties, conversion of agricultural properties to residential use, change of use applications and tree preservation work requests. The Parish Council will pass their concerns and objections to the Planning Department if we consider they will have a detrimental impact on the community environment.

On occasion requests have also been made to SKDC Enforcement for them to investigate when planning conditions imposed do not appear to have been kept to. The appeal for the traveller's site on the High Dyke was allowed by the Inspector, who decided to consider the appeal without permitting objectors to express their concerns to the Inspector in person.

This was very disappointing as the Parish Council had objected to this application on the grounds the site is unsuitable on grounds of safety for any potential residents, lack of any infrastructure or amenities and the impact on the area.

Legal advice was obtained on behalf of all neighbouring Parish Councils on the possibility of a Judicial Review application, but this was precluded by the potential legal costs involved and the very remote chance of overturning the decision. We receive regular scheme updates from the contractors building the east/west by-pass with an overview on progress and a look-ahead at forthcoming works, including traffic management updates.

You will have seen the current work on the relocation of the Somerby Hill roundabout which is now within our Parish. Parishioner's can keep up to date on the projects progress on the official website https://www.lincolnshire.gov.uk/gsrr The planned closure and development of the Prince William of Gloucester Barracks

site has now been put back to 2028. However, we will keep an eye on any developments and continue to seek the retention of as much of the Queens Jubilee Wood as possible.

Work on the Anglian Water pipeline phase from Wilsford to Harrowby reservoir is expected to start in the summer of 2022. Initial surveys have been made to ensure the route will cause the least disruption possible to the environment. #### What has your Parish Council done to celebrate this unique event?

After taking public feedback at the annual Parish Council Meeting the Council is acquiring a plot of land that will be established as a preserved natural habitat, and on this land a bench will be placed to overlook the parish as a long-lasting commemoration to Her Majesty The Queen. An Oak tree will also be planted and designated the Queens Oak as a permanent memory of the occasion. Also being considered is an Information Lectern describing the view from the seat. (We have been lucky so far that we have received £1000 in Grants & Donations towards this. Cllr Wootten £500, Cllr Chivers £250 both from their SKDC Councillors Grant Scheme and as you will see in the Tom Childs Award report £250 from Terry Claxton's donation.)

## What can you do to celebrate this occasion?

Sunday  $5^{\text{th}}$  June: The Big Jubilee Lunch: Every year since the idea began in 2009 The Big Lunch has encouraged communities to celebrate their connections and get to know each other a little bit better, coming together in a spirit of fun and friendship. In 2022 The Big Lunch will bring the Jubilee celebrations into the heart of every community.

People are invited to share friendship, food, and fun with neighbours as part of the Platinum Jubilee celebrations. A Big Jubilee Lunch can be big or small - street party or picnic, tea and cake or a garden barbeque. The Big Lunch provides tips and ideas for hosting an event.

### Parish Council Precept 2022-23

The parish council's total precept this coming year will be  $\pounds 33,000$ . Unfortunately, after four years of remaining stable we will have to increase it this year. This amounts to an increase for a Band D property of just over 2p per week. This of course, is less for bands A-C and higher for Band E and above.

The councillors who are guided by the Clerk/Responsible Financial Officer (RFO), have in most cases managed to remain within their set budgets. Increases that we are having to gear up for in 2022-23 are the Grass Cutting Contract plus other brought in services especially the Insurance and Newsletter printing. A new cost to us this year is that we now have a monthly charge for the banking services at HSBC. We are actively looking for other providers for our banking services.

Other smaller pots of income come from a grant from SKDC towards the cost of our Community Cleaner and Donations. Interest was another smaller income source, but this has basically dried up due to the much reduce rates on offer.

We believe this precept will enable us to meet our normal expenditure on services and allow us to continue with all the projects already in the pipeline.

Parish councillors are keen to provide the services that they are required to at the best possible rate. As you will continually see throughout this newsletter, we have several responsibilities that require resources annually.

Once again, our forward planning for the years 2023/24 and 2024/25 indicate that no major increases should be needed during that period. Though in these uncertain times this cannot be guaranteed.

As previously stated, forward planning is becoming ever more difficult as the years go by. We still expect more and more services to be passed down to the parish council level from the unitary authorities. Things we have highlighted before about how the government is expecting the parish to grow, means we are still not fully able to assess

the effects on our budgets. With the major building work planned for the Spitalgate area still not started it is difficult to assess the impact this will have on us. We are keen to continue with all the projects outlined in this Newsletter.

In this Newsletter you will see where some of the precept has been spent this year. Our Parish Clerk/RFO Pete Armstrong always keeps a close eye on our spending and councillors receive a detailed update at each meeting which is then agreed and signed off by the councillors. Councillor Vacancy

At present there is one vacancy on the Parish Council. We are inviting any interested parties to come forward as soon as possible, as we would like to fill this position at our "March Meeting". This will be done by the co-option method.

During the last few months, you may have seen our Speedwatch Team in operation around the parish, we have five locations in which we are licensed to operate. These are all around the Parish in Londonthorpe, Belton Lane, Sunningdale, Harrowby Lane and Alma Park Road.

The eleven registered volunteers take it in turns to make up the operating team of three. All members have done at least one session this year. We thank them for generously giving up their time to try and make the parish a safer place to live. All the sites are within the 30mph zones, but we consistently register drivers doing speeds near or over 40mph; one was caught on the gun at over 50mph. What has been most unbelievable is that the fastest have been near to the schools and during the time that pupils would be leaving the Belmont in the afternoon. These drivers obviously have no regard for anyone!

All drivers caught breaking the speed limit are reported to the CSW admin team who write to the driver or in the case of a business vehicle the company it is registered to. If a driver gets three of these letters police action may follow.

#### **National Trust**

I am really pleased to be able to give a positive update regarding the use of the Lion Gates pedestrian access.

Since reopening them in August we have had regular daily use of the parkland by visitors entering through the pedestrian gates and I'm really pleased to be able to report that we have had minimal instances of anti- social behaviour towards our team or instances of dogs harassing wildlife. I'd like to thank all those who use the parkland for respecting our team and the requests made to adhere to the by- laws in place.

There have been a few instances of people being locked into the property after the gates have closed and in the main this has been resolved amicably with only one instance of the tenant in Lion Gates lodge being verbally abused for not being able to open the gates. I would just like to take this opportunity to remind visitors to check the closing time on the gates when they enter so they do not get locked in and find themselves faced with a long walk back to the main entrance to get out.

The only area that continues to be a concern is the number of cars and people that park outside the gates and walk into the wider "pay for entry" estate to use the facilities such as the playground without paying the entry fees. This is particularly prevalent at the weekend and over the Christmas period. I'd like to take this opportunity to remind

anyone wishing to use the full property facilities that they must go to the visitor reception and have their membership card scanned if relevant or pay the entry fee. Over the coming weeks and months, we will start to administer this by having someone in place near the oval and river path to advise those entering the pay for entry area of this.

We will continue to monitor the use of the pedestrian access and update the Parish Council regularly.

Thank you for working with us to make sure that the Belton Parkland remains a beautiful place to walk and enjoy.

## Parish Council Working Parties Report

We have held one more session at the **Withambrook Amenity Area** to continue raising the crowns of the trees bordering the industrial estate. This was as we pointed out last year necessary to meet health and safety legislation. What remains now though is to continue cutting back and upwards to regain ground lost from the grassed area. We will need at least one more to complete the task. This one though will again be more for maintenance than any safety issue. The work done at the latest event gave us approximately four metres more grassland.

As you will see in the Hills & Hollows report another was held up there in the

autumn where a large area of tall grass was cut down to encourage more flora to come through. The work done last vear at Londonthorpe left a lot of brash to be cleared and we are very grateful to Cllr Paul Bavin for allowing us the loan of one of his men and an Industrial Shredding Machine to clear all this.

## Londonthorpe Village

We are at present trying to get planning permission for the diseased Cherry Tree on the Church Green to be removed. It was planted to commemorate Londonthorpe winning the "Lincolnshire Best Kept Village Competition"

This tree over the years has been very poorly treated by Western Power contractors whilst keeping it clear of the power lines. This has left it with a very poor shape and a hole in the middle. It also has Canker; we have already had to remove some dangerous branches over the years. This will be replaced as soon as possible by the Village Volunteer Group.

### Blessed Hugh More School Site Update.

It may seem to you all that the parish council have sat on this and been doing nothing, but that is far from the truth. Since the ACV was granted, we have been constantly trying to get the correct permissions to enter the site and do what we believe are at least the bare minimum actions required, e.g., the improving of the entrances.

What must be understood is that the ACV and the Licence are two totally different things, we know some people were mixed up over this.

Over the last few months, we have been dealing with the fourth different person since we started on this. This means all continuity was lost each time and we basically had to start afresh.

We were getting nowhere until the Clerk wrote to the Leader of the Council, the Chief Executive, the Head of Housing Revenue and also copying in our District Councillors. Both of our councillors contacted the above officers for us, and a more informative reply was forthcoming shortly afterwards.

Since then, we have moved on to the Licence as mentioned above and we are waiting for a reply from SKDC's solicitor to our latest queries.

By permissions this means a Licence, of which we have seen a draft, and we do not like some of the restrictions etc. We have also requested some clarity on other items that we may wish to consider but not included in this draft. Two of the items that raised concerns were:

- Anything that the parish council puts on the site then becomes the property of SKDC (HRA Account). This is ongoing.
- The Scrubland to the south, is this included as it is on the original plan? (We now know that it is a separate entity)

The parish councillors are keen to see this through but not at any expense, after all it will have to come out of our precept unless grants can be obtained. We will be looking to obtain these grants as soon as we get the go ahead.

When we first requested quotes for the entrances the costs were expected to be around £10000 in the materials that we had in mind. That cost will have risen considerably since, so other materials may have to be considered. We are awaiting new quotes as this article is being written. The Clerk met with one of the contractors recently and expects the quote to arrive within the next few days.

#### \*\*\*\*\*

You may have also heard the Parish Council are in the process of taking over the piece of land just above the BHMS, from Jenkinson Farms Trust. They offered us it for minimum sum. On this land we intend to put a Commemorative Bench, as stated elsewhere this is part of our Platinum Jubilee efforts. We are hoping that local residents will come forward to help make this a place to sit and take in the marvellous view.

## The Hills & Hollows Update

The site is looking good, and the improvements made year on year by our volunteers is very noticeable and much appreciated. A special mention must be made to Tony Parker who has continued to trim back the hedges during the whole of last year helping to keep the track open. We thank him for that. (see Tom Childs Awards)

Members of the public using the area who we have spoken with are all very complimentary about all we are trying to achieve. As we have seen an increased footfall on this site, the paths have become very muddy at times, please take care. Unfortunately, not everyone who uses the area is as considerate as they should be, this brings about more problems for us. Most people are verv



respectful of the sensitivity of the area, but a few don't seem to be bothered. In one incident recently we have had a fire reported to the emergency services. In this instance some one used one of our piles of brash for a fire, luckily no harm was done as it burnt itself out. If this had been in drier conditions, it could have spread widely across the whole area.

When we do the burning on site it is controlled until it has gone out. We are incredibly lucky to have people who use the site regularly and help to look after it properly for the benefit of others We sincerely thank you for that.

During the year we have had more on-site meetings with up to five volunteers. The work undertaken included the hiring of a wheel strimmer which enabled us to cut back some of the longer grass. Already we can see signs of regeneration of plants that were hidden below this overgrown mass.

As mentioned in the autumn update, our success rate with the trees planted last spring was very poor, those that failed were replaced by our suppliers Thorpe Trees free of charge. The replacements were planted in November along with three more donated trees.

Although the Memorial is full, we have allowed trees to be planted in other Locations on our land.

We were due to receive three trees from the Lincolnshire Treescape Scheme, but of those that we did get only one was deemed suitable for this site. As an alternative we are going to plant two more fruit trees as the holes are already dug. We are hoping to arrange a working party on a weekday in early/mid to May to do more maintenance work. (Contact the clerk if you would like to be involved.)

As mentioned in the Leisure & outdoor report the Granite Seat that Vale Sport & Play donated to us has been positioned to give a wonderful view down the Vale of Belvoir. This is yet another improvement made by the Parish Council. We do 11
